Cllr Proudfoot requested to make a proposal to submit an Expression of Interest to Heritage Lottery Funding to hopefully secure some additional funds to support the project.

A query was raised regarding the £10,000 reference in the Parishioner Survey. It was noted that while the Parish Council have majority support from parishioners, to use up to £10,000 towards the project, there has been no resolution passed by the Council. No Parish Council funds can be used unless approved by the Parish Council. The hope is that it will not be accessed, as MPC plans to secure funds from alternative grants, ie Cornwall Council Community Infrastructure Grant and Heritage Lottery Funds to make up the £38,000 shortfall.

Following a review of the Community Ownership Fund, and subsequent discussions, the following resolutions were resolved:

To approve inclusion of 'Support in Principle from BSTC', 'What can Local Councils Do' & 'Parishioner Survey Information' documents to the application. Proposed Cllr Perry. Seconded Cllr Waterhouse. Unanimous.

To approve inclusion of Letters of Support, Ecological Survey & RICS Valuation Report. Proposed Cllr Biddick-Bray, Seconded Cllr Waterhouse. Unanimous.
