

Marhamchurch Parish Council

Tuesday 17th October 2023

The meeting of Marhamchurch Parish Council was held on the above date at 7:30pm, in Marhamchurch Sunday School Rooms.

Councillors Present:

22 members of the public were present for the meeting.

Cllr Perry opened the meeting and welcomed everyone.

Record and Approve Apologies.

10.23/200:

Cllr Kerr sent apologies as he is away. It was resolved to approve the reason for the apologies. Proposed Cllr Proudfoot, Seconded Cllr Bray. Unanimous.

Inquorate Meeting 5th September 2023.

10.23/201:

The last meeting which was held on 5th Sept 2023, was inquorate, as there were only 3 Cllrs present. Advice from CALC as follows:

The quorum for any meeting of the council is based on the number of seats rather than the number of councillors. As the council has 10 seats the quorum will always be 4 (3 or 1/3 whichever is the greater round up for whole numbers). If only three members were present then the meeting will have been inquorate and you will need to ratify those decisions at the next meeting of the council.

10.23/206:

Gemma Watton spoke about the Crematorium and extended her thanks to Marhamchurch PC for their support. She also spoke briefly about the Hele Trail and gave some information and contact names which may be able to provide assistance to Marhamchurch PC. She will email details over to the Clerk.

Resident of Marhamchurch spoke about the importance of the Hele Trail for many users locally and in the broader community.

With agreement of the Council, it was decided to bring forward Agenda Item 11: Hele Valley Trail.

Hele Valley Trail.

10.23/210:

A hugely important and valuable resource for the Marhamchurch and wider community, it would be devastating to lose this space. It was noted that the Hele trail falls within Bude & Stratton TC boundaries.

Cllr Proudfoot updated that in her opinion the only option was to look into options to purchase the trail, and she had been exploring funding options. These included Cornwall Wildlife Trust, Woodland Trust, National Lottery and the possibility of the Parish obtaining a public works loan to purchase the land.

As far as PC are aware, there is no income generated from the Trail but ongoing maintenance costs would need to be factored in, which may well be minimal.

Cllr Chopak updated to say that Community Levelling Up funding may be available, and that Crowdfunding could also be a useful option with guidance available from Cornwall Council to set this up. Cllr Chopak also talked about requesting a Definitive Map Modification Order application to Cornwall Council, and that letters of support for this from residents would be very helpful. Cllr Chopak also mentioned that offers of maintenance support had been received.

Cllr O'Sullivan raised the matter of Asset of Community Value, which was discussed at BSTC meeting. He flagged concern that this would not be beneficial, as the land is already for sale, and the AoCV could take months to be processed. Cllr O'Sullivan proposed that contact be made with BSTC to state that Marhamchurch PC feel that pursuing an application to list the land as an Asset of Community Value, will not be helpful or productive and that MPC do not support this idea. Proposed Cllr O'Sullivan. Seconded Cllr Proudfoot. Unanimous.

- (iii) **PA23/03104** | Construction of two storey dwelling to include enclosed private amenity and parking. Land South West Of The White House Hobbacott Lane Marhamchurch Bude Cornwall.

Although Marhamchurch PC have not been asked to comment on the ongoing matter, it was requested to be listed at our last meeting for discussion.

Following latest comments from Highways, and further to previous comments made by Marhamchurch PC, it is reasonable that the application be refused. The Council were unanimous in this decision. Proposed by Cllr O'Sullivan. Seconded Cllr Proudfoot.

- (iv) **PA23/07463** | Non material amendment in relation to decision notice PA17/02783 dated 19/09/2018 to allow the addition of 16 PV panels per a unit, located on both sections of the wing roof | Whalesborough Farm Marhamchurch.

Marhamchurch PC have no objections to the amendment, and were unanimous in their position on the matter. Proposed by Cllr Edwards. Seconded Cllr Bray.
